

We are pleased to confirm that, from the week commencing 1 June 2020, Alveley Primary School and the other primary schools in our Trust will welcome back children in Nursery, Reception, Year 1 and Year 6, alongside priority groups. This is on the understanding that the Prime Minister gives the 'green light' at the end of May for primary schools to begin re-opening.

We have worked exceptionally hard and very carefully as school leaders across our Trust, but also here at Alveley Primary School, to be ready to re-open safely and securely. We have looked at all aspects of health and safety and we have made many changes to how we work and how we use space. All of these changes are in line with the extensive guidance we have received from the Government, and Shropshire health and safety professionals. Our approach has been fully checked and authorised by the Trust. We hope that this reassures you.

We understand that many parents with pupils in Nursery, Reception, Year 1 and Year 6 may be keen to get their children back into school. We understand that others amongst you may feel that this is not the right time yet for your family. We are seeing the attendance of pupils in those year groups as entirely voluntary and there will be no poor attendance 'mark' for those not attending.

You have already told us whether or not you intend to send your child to school on 1 June, if you have a pupil in a relevant year group. There are a few things that we need these parents to be aware of:

- We have made up small groups of pupils who will spend their school time together with specified staff. This is to limit pupil and adult contact across our school. We are calling these groups 'pods.'
- At the present time pods will have around 10 pupils, although this may change over time. .
- We will be working hard to socially distance pupils within these pods, but for younger pupils especially, we know that this is unlikely to be 100% successful. We will endeavor to manage a 2 metre distance between tables but this may not be always possible. Contact between children in different pods will be very controlled and at an absolute minimum.
- Contact between children in different pods will be very controlled and at an absolute minimum.
- We have also been asked to limit the contact of different adults across our groups of children. We are therefore keeping the adult working with a group as consistent as possible. With this in mind, our teachers will carry out their planning and preparation on Wednesday afternoons, when we will close to pupils except for those of key workers. Please contact the school if you would like to talk to us about a problem related to early closure on Wednesday. **School will close every Wednesday at the end of the morning** (see reverse for details).
- If you had decided not to send your child back to us yet, and you change your mind, please give us some notice. We will need to assign your child to a group, and we may need to alter our arrangements to accommodate it. Similarly, if you are a key worker and there is nobody else in your household available to look after the children and now need your child to start attending school again, please contact us to discuss your individual circumstances.
- We will be operating staggered start and finish times which are on the reverse of this letter.
- We will not be able to allow adults / visitors into our buildings unless for specified reasons. For this reason, please telephone or email the office rather than drop in.
- There are school specific arrangements that we need you to be aware of which can be found overleaf.
- There are specific things we need your child to bring / not bring to school which can be found overleaf.

- If you are planning for your child to now restart attending school, please talk through with them these arrangements. Specifically, please talk to them about:
  - they will be in a new little group of pupils when they are at school and in a particular room for much of the day.
  - it will be great to see their classmates again but, when they are at school, they will be doing more activities at their desk than they are used to, and the teacher will ask them not to get close to each other.
  - The way we are managing arrivals. Many younger pupils are used to parents settling them into class. Under the new regulations, 'hand over' will happen outside of the buildings where a designated staff member will meet you and take your child in.
  - Most importantly, it is vitally important that no child or adult attends school if they are ill. I am sure you are all aware of the 14-day quarantine for families with CV illness and so on. We will be sending out a reminder letter about this in due course.
  - If at all possible, please look at some information that you can pick up from this website: <https://www.e-bug.eu/>. It is designed to explain current health issues in a child friendly way. We will send this out to pupils as important learning activities to complete this week.

At the present time we will be working hard as a school to work in these new ways. We are aiming to continue to ensure that the quality of Distance Learning for those at home continues. However, this will inevitably change as teachers will now have to divide their time between educating pupils in school and also at home. Thank you for your understanding and patience.

We would like to take this opportunity to thank you for your understanding and patience as we have all had to get used to a new way of educating pupils at home. Thank you also in advance for your understanding and patience as we get used to some very different practices and ways of working going forward.

Please be aware that our arrangements for nursery aged children are slightly different. This is a non-statutory year group, and to make it work safely we will need to restrict days and times available to parents at present. Unfortunately, we cannot safely offer more than 15 hours at the present time, these sessions will be allocated in the morning and children will return home for lunch at 12pm. Thank you for your understanding.

## Alveley Arrangements

Please see below the arrival and collection times for each pod. We would ask that you follow these times to ensure social distancing can be maintained at our main entrance and exit points.

We would ask that where possible only one person accompanies a child at drop off and pick up times. At Alveley we will have a one-way system around the site.

ONE-WAY SYSTEM: Please **enter** through the **pavilion gate** and follow the one-way system around the outside of the building to **leave** via the gate on **Daddlebrook Road**. Each class will have a designated drop off and pick up point outside the classroom door (at Oak, Cedar and EYFS). We would ask that social distancing is maintained whilst waiting outside each classroom.

**NB All children will need to be picked up at the above time, please note times on Wednesday (except those of keyworkers).**

LUNCHES – school meals WILL NOT be provided for the first two weeks. Please send your child(ren) into school with a packed lunch and a drink, also a water bottle for drinks during the day. The FSM vouchers will continue for those parents who are currently receiving them.

BELONGINGS/RESOURCES - All stationary will be provided in individual sets. Children do not need to bring school bags, toys or teddies.

CLOTHING – The wearing of school uniform will not be necessary but, to avoid cross contamination, we do ask that the children come to school each day in fresh clothes. As we intend to use our outdoor spaces as much as possible, children should wear appropriate clothing (including a coat) with sunhats and suncream already applied on days where good weather is expected.
